1. Profile:

Bureau of Economic Research (BER) is a research organ of the University of Dhaka. It is the organization through which mainly the faculty members belonging to the Department of Economics conduct their research activities. The office of BER is located in the University Arts Faculty Building. Since its inception in 1956, the Bureau has completed a number of studies, has provided a store-house of research experience and has been a source of trained hands for employment by government and private agencies. The Bureau undertakes research projects whenever such studies appear to have prospects of making a clear addition to knowledge in the related field. Some projects are also undertaken in collaboration with other research organizations. Bureau of Economic Research, University of Dhaka, is passing its 65th year of activities during the session 2021-2022. During this session Prof. Dr. Mahbubul Mokaddem Akash acted as Chairman of the Managing Committee of the Bureau and Prof. Dr. Selim Raihan has been acted as Director of the Bureau of Economic Research, both are from the Department of Economics, University of Dhaka. 2. ORGANISATION:

The affairs of the Bureau are managed by a Secretariat headed by the Director (Vide Section V of the Constitution). The Director is controlled by a Managing Committee constituted according to Section III of the Constitution. The Managing Committee of the Bureau is composed with the Chairman and all Professors of the Department of Economics, Dhaka University, Director of the Bureau and the Director-General of the Bangladesh Institute of Development Studies (Ex-officio). In order to make the Managing Committee mote representative, a representative from the Bangladesh Planning Commission and 2 scholars interested in research are also nominated to the Managing Committee by the Vice-Chancellor.

There is a full time Secretary who looks after the routine office work. Project Leaders operate independently except in matters like finance, leave rules, recruitment etc. that require a uniform policy.

- **2.1. Name:** The name shall be the **Bureau of Economic Research**, Dhaka University.
- **2.2. Objects and Functions**: The Bureau will conduct as well as promote research in the fields of economic and related subjects. The Bureau will not be precluded from undertaking research in the general field of social sciences which have a bearing on the above fields. It is hoped that this research will help in improving the quality of teaching by providing data as well as an analysis of economic and social problems. In particular, the research will be aimed at finding solutions to many practical problems which will help in policy making in national development. An important part of the programme of the Bureau will be concerned with the training of research workers at different levels, particularly graduate students, so that they can take up independent research work.

- **2.3. Managing Committee**: The Managing Committee of the Bureau will be composed of the following persons:
 - 1. Chairman of the Department of Economics, Dhaka University.
 - 2. All Professors in Economics, Dhaka University.
 - 3. The Director of the Bureau of Economic Research (Ex-officio).
 - 4. A representative of the Planning Commission, Government of Bangladesh to be nominated by the Vice-Chancellor.
 - 5. The Director-General, Bangladesh Institute of Development Studies, Dhaka (Ex-officio).
 - 6. Two nominees of the Vice-Chancellor from amongst persons interested in research.

The Managing Committee will have the overall responsibility for the activities of the Bureau. It will approve the selection of projects, appointment of Project Leaders and review the work of the Bureau at least once in three months and report to the Vice-Chancellor about the progress of work annually. It will appoint an Auditor. It will approve the budget and frame service and leave rules etc. for the employees. Until a meeting of the Managing Committee is called the Chairman shall be able to exercise the powers of the Managing Committee. The Chairman will convene meetings of the Managing Committee when necessary. The Managing Committee will frame resolution for the proper management of the affairs of the Bureau and for the running of its day-to-day business (a) "At least one-third of the Members of the Managing Committee must be present at any meeting of the Managing Committee to form a quorum". (b) "In case the Chairman of the Managing Committee is absent in a Meeting convened by him, the Members of the M.C. present, will nominate one from amongst them to preside over the meeting".

2.4. Chairman of the Managing Committee: The Chairman of the Managing Committee will be appointed by the Vice-Chancellor for a term of two years amongst the Members of the Managing Committee other than the Director. Members nominated by the Vice-Chancellor will serve for two years unless they resign before that time.

- **2.5. Director**: The Director of the Bureau of Economic Research will be the executive head of the Bureau exercising the powers delegated to him by the Managing Committee. The Director will be appointed by the Managing Committee for a term of three years subject to the approval of the Vice-Chancellor. The Director will be the drawing and disbursing officer of the Bureau and will operate the accounts of the Bureau jointly with the Chairman of the Managing Committee. Until a Director is appointed, the Chairman will exercise the powers and functions of the Director.
- **2.6. Research Projects**: A research project may be initiated by the teachers of the Department of Economics and any other interested Department / Agencies that would submit their proposals to the Director for the consideration of the Managing Committee.
- **2.7. Project Leader**: The Director will make recommendations for a Project Leader to the Managing Committee. After a project leader is appointed by the Managing Committee, he may have autonomy in the technical direction of the project and the completed study can be published in his name but he will be under the executive control of the Director. The Director of the Bureau will have the overall responsibility for the co-ordination of work of individual Project Leader. The Director will report about all the projects to the Managing Committee every three months. The Director will be the Project Leader for the projects initiated by him.
- **2.8. Secretary**: The Secretary of the Bureau will assist the Director by undertaking the routine official work delegated to him, attend to accounts, manage the Library and do such other work as may be assigned to him by the Director.
- **3. Major Activities:** Three major activities of BER. These are discussed below:
- i) Research in social sciences and other socio economic fields.
- ii) Providing different types of training for capacity development, and
- iii) Dissemination of knowledge through workshop, seminar, symposium and conference.
